Green Pattern Hunter Under Saddle: Copy of horse's show record indicating 10 points or less in Hunt Seat Equitation and 15 points or less in Equitation Over Fences as of January 1, 2017 per class (NOTE: AQHA Level 1 documents do not satisfy this requirement)

WCHA Performance Halter
