# REPORT: Investment Policy Updates - Beth, Ryan

Investment Policy Statement- NSBA & NSBA Foundation. Clarifies investments, will be a public document, working document. Draft for approval in September 2022 with plans to start investment in fall of 2022.

Merrill Lynch Financial Advisor Group – NC Recommended by Phil Harris. Conservative (defensive) presentation. Collective funds are more advantageous funds for Foundation and Association funds to be pooled at this juncture. The joint Association and Foundation financial committee included, Beth Hartman, Ryan Cottingim, Mike Laplace, Michael Tidwell (NSBA Treasurer), Janet Gunn, Charles Cannizzaro, Phil Harris, Clay MacLeod, Kevin Dukes and Stephanie Lynn.

Proposed portfolio 9.54% 10-year return, philosophy managing downside risk is critical to long term success, majority of companies will be dividend paying, suggested mix 65% equities/35 % fixed income assets. Other companies looked at include private equity management and local wealth management.

**Unfinished Business: Plan of Work**

- Options for marketing discussed; announcement, mailing not effective, Social Media, at the horse show still the best place to raise awareness
- Goal to have 50 trainers commit to program with \$500 donation from client in return for training services
- Request to provide Stall Chart to Board Members prior to horse show, plan for awareness campaign and discussions, stall charts are available online
- Desire from to rename
